Our approach

1) Simple logit models :

→ Micro economic approach based on individual preferences

2) Nested logit models :

→ To capture substitution patterns based on individual's and destination's characteristics

Gallup World Poll Data (2023) : representative of 99 % of the world's adult population

Migration related questions :

- WP1325: *Ideally, if you had the opportunity, would you like to move permanently to another country, or would you prefer to continue living in this country?*
- WP3120: *To which country would you like to move? (Asked only of those who would like to move to another country.)*

Data

⇒ 17% of respondents express a desire to relocate

Logit model

Discrete choice model framework

Utility for country c, individual n :

$$U_{c,n} = V_{c,n} + \epsilon_{c,n}$$

where $V_{c,n}$ is deterministic and $\epsilon_{c,n}$ distributed

Random utility maximization principle where \mathcal{C}_n is the individual choice set :

$$P_n(c|\mathcal{C}_n) = P(U_{c,n} > U_{j,n} \forall j \neq c, j \in \mathcal{C}_n)$$

⇒ $P_n(c|\mathcal{C}_n)$ depends on the distribution of the $\epsilon_{c,n}$

Logit model

Expression

Assumption : $\epsilon_{c,n}$ iid $EV(0, \mu = 1)$ across c and n

Derived probability :

$$P_n(c|\mathcal{C}_n) = \frac{e^{\mu V_{c,n}}}{\sum_{j \in \mathcal{C}_n} e^{\mu V_{j,n}}}$$

Utility to stay

Variables in the utility to stay

- Age
- Education level
- Income
- Gender

Logit model

Utility to move, country c

Variables in the utility to move to a country c

- Diaspora
- Population
- GDP
- Distance
- Language proximity $\in [0, 1]$
- Contiguity · GDP difference between c and origin country

Logit model

Utility to move, UK

Additional variables in the utility to move to the UK

- Uncertainty period · Education level
 - Post-Brexit · Education level
 - Education level
 - Origin specific constants
-
- Pre-Brexit period : 2012 - June 2016
 - Uncertainty period : June 2016 - 31 december 2020
 - Post-Brexit period : 1st January 2021 - 31 december 2022

Logit model

Estimation

- Estimation done with the Biogeme software
- Sample is of size 96685 (60000 sampled intended stayers + 36685 intended movers in the base)
- Common choice set of 150 countries of destination

→ Intended stayers' utility coefficients are consistent with the litterature

→ Need to include group destination constants for future nests : OECD, Schengen, English-speaking

Logit model

Limitations

Limitations of the multinomial logit model :

- ⇒ Irrelevance from independent alternatives (IIA) property : cross-elasticity for destination j is the same across all other destinations
- ⇒ We need models that can capture better the substitution patterns

Nested models

Nesting structure idea


Nested structure : capture unobserved shared attributes between alternatives

- Intended movers might share unobserved characteristics that differ from intended stayers
→ Exclusive nests : **nested logit model**

- English-speaking countries, Schengen countries, OECD countries might as well share unobserved characteristics that differ → Overlapping nests : **cross-nested logit model**

Ideas and hypotheses

H1 : Brexit affected people's migration patterns only through the visa channel

- Only citizens from EU are affected → previous models showing a negative impact of Brexit
- Non EU citizens entry conditions haven't changed → Brexit shouldn't have an effect

H2 : Brexit reduced global attractiveness of the UK

- Citizens from EU are affected → previous models showing a negative impact of Brexit
- Non EU citizens are also affected → Brexit should have a negative effect

→ 5 non EU countries : Albania, South Africa, Turkey, Nigeria, Australia

→ Problem : Significant missing data for diaspora that biases the estimation

→ Solution : Restrict the choice set to countries for which we have the data

→ Diaspora, GDP and Population have consistent signs

→ Most of the Brexit coefficients are not significant → H1

→ Except for Low skilled after for which we have a negative effect → H2

Conclusion

Conclusion :

- Low skilled workers : decrease of UK attractiveness after implementation of measure
- Middle and high skilled workers : decrease of UK attractiveness in both periods
- Placebo countries : differentiated effect around the globe

Further steps

- Nested models estimation
- Investigate other countries for the Placebo
